

## A. STUDENT CONSENT AND RELEASE

This consent and release includes but is not limited to the right to:

1. Make and copyright text, photographs, audio and/or video recordings of my image and voice as part of the University’s educational or related purposes.
2. Use, produce, modify, distribute, disseminate and assign works in any form, manner, or mode of electronic transmission for educational or related purposes.

In connection with this grant, I release the University and its assignees from any and all claims and demands related to such use of my coursework, talent, image, voice, performances, or audio or video representation of myself, including any and all claims for copyright infringement or invasion of privacy, contained within the works.

In accordance with the Family Educational Rights and Privacy Act of 1974 (as amended), the University does not release a student’s educational record information without the written consent of the student, except to certain categories of persons or organizations specifically exempt by the law. A student’s consent is not required to release information to school officials; to federal, state, and local authorities involving an audit or evaluation of compliance with educational programs; in connection with financial aid; to organizations conducting studies for or on behalf of DU; to accrediting organizations; to parents of a dependent student; to comply with a judicial order or subpoena; in a health or safety emergency; or the results of a disciplinary hearing to an alleged victim of a crime of violence.
